

Health Guarantee



Breeder (hereafter referred to as Seller): _____

The Seller guarantees the puppy to be of good health at the time of purchase. The Seller will provide Buyer with a health record of all vaccinations and worming as well as a veterinarian examination of the puppy.

Buyer agrees to take puppy to a veterinarian within 10 days of the date they take possession of the puppy. If the veterinarian believes that the puppy is not healthy and has a life-threatening illness, the veterinarian's findings shall be documented in writing within 10 days of the date puppy is received. All documentation must be accompanied by the veterinarian's contact information. Seller will have the condition confirmed by their veterinarian. If the condition is validated by Seller's veterinarian, the Buyer may return the puppy to Seller for a full refund, or replacement puppy. If the condition is treatable, it is NOT considered life threatening.

If the puppy dies within 12 months of its birthdate from a suspected congenital defect, an autopsy must be performed at the Buyer's expense by a veterinarian to determine the cause of death. If the autopsy shows a congenital defect as the reason for death, the puppy will be replaced at no charge. A written statement from the licensed veterinarian must be provided with the Seller's name. If no autopsy is done to determine the cause of death, no refund or replacement shall be given to Buyer. In no circumstance, shall the Seller refund the Buyer more than the puppy's purchase price from Seller. No shipping or delivery fees shall be refunded to Buyer.

The Seller is not responsible for any veterinarian bills incurred once the puppy is in the Buyer's possession, the Buyer assumes all responsibility for the puppy. Buyer understands that adult sizes are an estimate only, based on Seller's experience. Buyer acknowledges that there is no guarantee on final adult weight, actual size, hair color or eye color. This guarantee does not cover any veterinarian costs associated with spaying or neutering, including undescended testes. Seller does not warrant against any condition caused by carelessness, negligence or abuse.

The Buyer agrees to provide a life-long commitment, comfortable environment, prompt medical attention, proper grooming and responsible care. The Buyer promises to provide a safe environment for the dog and never allow the dog to roam freely without proper fencing or supervision. Seller is not responsible or liable for payment of ANY medical, dental, or surgical procedures to maintain the animal's health or well-being after the time of purchase.

Failure of the Buyer to take the puppy to a licensed veterinarian within 10 days of purchase date will void this health guarantee. Breeding this puppy within 12 months of its birthdate shall void this health guarantee.

Puppies are sold as family companions. Seller cannot guarantee the breeding, hunting or show ability of any puppy.
